### Where to Find a Company's Annual Report and SEC Filings?

Each broker or dealer that computes certain of its capital charges in accordance with § 240.15c3-1e must file concurrently with the annual audit report a supplemental report on management controls, which must be prepared by a registered public accounting firm (as that term is defined in section 2(a)(12) of the Sarbanes-Oxley Act of 2002 (15 U.S.C. 7201 et seq.)).

### 17 CFR § 240.17a-5 - Reports to be made by certain brokers ...

The SEC has a process for electronic filing of annual audit reports, in lieu of filing in paper form, which the SEC simplified and updated in January 2017. [1] Members are reminded that the SEC requires firms to obtain EDGAR access credentials in order to be able to file electronically. [2] The process for obtaining such credentials may take several days and members are encouraged to request the access credentials prior to the due date of their filing in order to ensure timely submissions.
