The First Amendment of the Constitution states that "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof." Thus, the "separation of church and state" is rightly understood as government not establishing one religion, one set of beliefs or view of life as the religion of the nation, but instead exercising its responsibility to protect in law a multitude of beliefs, both religious and otherwise.
