Generally, in most M&A Transactions, the seller will be the party disclosing Confidential Information, but, in certain transactions, such as where the buyer will be issuing its equity securities as part of the transaction consideration, the buyer may also be providing Confidential Information to the seller in connection with the seller's due diligence on the buyer.

### **Beware of "Residuals" Clauses in NDAs for M&A Transactions**

And this formulation is the common approach in the private equity world, where the acquisition/pursuit vehicle or the portfolio company is the only named party to the NDA, but a defined group of representatives or permitted recipients, including certain affiliates, are identified as being persons with whom the named party is permitted to share confidential information, and the named contracting party agrees to be liable for violations of the NDA by those other permitted recipients.

a confidentiality agreement is generally negotiable, notwithstanding any claims by [the seller] that the draft is a 'standard form' or that every bidder is being asked to sign the same," said Igor Kirman in his book M&A and Private Equity Confidentiality Agreements Line by Line.
