The Department of Health approves applications for approved providers under the Aged Care Act 1997 (the Act) to deliver residential aged care. We allocate places and capital grants to providers through the Aged Care Approvals Round (ACAR) .

However, you cannot access residential respite care if you are already permanently living in an aged care home. Read more about residential respite and how to access these services. You can check if you are eligible for an assessment OR apply online for an assessment, or call My Aged Care on 1800 200 422 to get started.

You need an income and asset assessment if you want help with the costs of residential care. You need to apply for an assessment for residential care if either: you're a self funded retiree. you own your own home and get a means tested income support payment.

entered care before this date, you will need to request a new assessment. After you enter permanent residential aged care you generally do not need to apply for another. assessment unless you have moved or are intending to move into a new aged care facility or have a significant change in assets and/or income.

How much you will have to pay depends on the place you choose and an assessment of your income and assets. Typically, there are three types of costs associated with all aged care homes: A basic daily fee (the maximum is currently \$52.25 per day) A maximum amount that everyone pays for the hotel services they receive.

### Aged care homes | My Aged Care

Aged care fees and charges All permanent aged care residents, may be asked to pay a basic daily fee as a contribution towards such things as food, heating/cooling, cleaning and laundry. In addition, some residents may also be required to pay a means tested care fee.
