Juvenile Sex Offender Treatment: How are We Doing & Where ...

Laub et al. (1998), using the Gluecks' data on 500 juvenile offenders from the 1940s, found that only 25 percent of them were still offending by age 32. Much research has concentrated on the onset of delinquency, examining risk factors for onset, and differences between those who begin offending early (prior to adolescence) versus those who begin offending in midadolescence.

First, a juvenile is screened by a court intake worker who compiles demographic data, social history and record of offenses. Second, there is psychometric testing to determine if the juvenile is a candidate for diversion, probation, incarceration or inpatient or outpatient treatment at a mental health facility.

By studying the distribution of federal funding for SROs and rates of school-related arrests, criminologist Emily G. Owens found that the presence of SROs on campus causes law enforcement agencies to learn of more crimes and increases the likelihood of arrest for those crimes among children under the age of 15.

The current study investigates the offending trajectories of juvenile sex offenders (JSOs) across and beyond adolescence. In doing so, the study examines the number, the rate, and the shape of nonsexual and sexual offending trajectories in a sample of JSOs followed retrospectively and prospectively from late childhood to adulthood.

The researchers concluded that young adult offenders ages 18-24 are more similar to juveniles than to adults with respect to their offending, maturation and life circumstances. Changes in legislation to deal with large numbers of juvenile offenders becoming adult criminals should be considered.

From Juvenile Delinquency to Young Adult Offending ...

A juvenile offender does not become so suddenly, at the time of the commission of a crime. As a rule, the antisocial properties of his personality are formed gradually and long before the commission of a crime, which gives rise to a qualitative new socio-legal assessment of his personality as a juvenile offender.
